GUIDELINES FOR REGISTRATION AND REGULATION OF PRIVATE HEALTH FACILITIES IN BAUCHI STATE

INTORDUCTION

In accordance with the provision of <u>Gazette – BA.S.L.N. No. 6 of 1986</u>, which provides the guidelines for registration and regulation of **Private Health Facilities and Stand-alone Laboratories** in Bauchi State as follows:

REQUIREMENTS

1. Submission of Application

- a. Letter of Intent by the proprietor, addressed to the Honorable Commissioner of Health
- b. Copy of Certificate of registration with Corporate Affairs Commission (CAC)
- c. Copy of Tax Clearance Certificate
- d. Introductory letter from the host's LGA
- e. Graduating Certificate of the Operating Officer
- f. Registration Certificate of the Operating Officer
- g. Current practicing License of the Operating Officer
- h. Letter of undertaking of the Supervising Doctor (for Health Clinics, Nursing & Maternity Homes)
- i. Graduating Certificates of Professional Staff
- j. Registration Certificates of Professional Staff
- k. Current practicing Licenses of Professional Staff
- I. State Fire Safety Certificate
- m. State Waste Management Board Registration
- n. Payment of pre-registration fee

2. Pre-registration Inspection

- a. Physical Inspection of the facility
- b. Report of physical inspection
- c. Approval for registration
- d. Payment of registration fee

e. Certificate of registration

3. Annual Renewal of registration

- a. Payment of annual renewal fee
- b. Annual Certificate of registration

PROCEDURES

- a. An applicant will write a letter of intent to the Hon Commissioner of Health attaching all the relevant documents stated above.
- b. If all requirements are met, the applicant will proceed and make payment (<u>Bauchi State Tax Harmonization Law, 2020 page 59</u>) according to the category of the private health facility for Preregistration Inspection, which is a physical inspection by a team of inspectors called "PHFRRA", within 2 days.
- c. The payment is made through a Revenue Officer in the Ministry of Health, who generates a Remitta to the applicant for subsequent payment through the TSA of the State in less than 1 hour.
- d. Upon the completion of a successful inspection, the report is forwarded to the Honorable Commissioner for approval for registration as a Private Health Facility within 7 days.
- e. Upon receiving approval, the applicant would obtain a remitta from the Revenue Officer of the Ministry at No. 1 Off Bello Kirfi Way, PMB 065, Bauchi, Bauchi State, **Contact No +2347066746422**, for payment of a non-refundable Registration Fee (Bauchi State Tax Harmonization Law, 2020 page 59) through the CRF account (TSA).
- f. The applicant is then issued **Certificate of Registration** to operate a Private Health Facility within 7 days.
- g. The applicant is now certified to operate a Private Health Facility.
