REPORT ON THE CONDUCT OF THE BAUCHI STATE 2023 BUDGET PUBLIC HEARING IN THE 3 SENATORIAL DISTRICTS

INTRODUCTION:

The purpose of the Budget Public Hearing (BPH) as an integral component of the Multi-Year Budgeting framework (MTEF) is to open and widen opportunity to the stakeholders at all levels Development Partners, Donor Organizations, Non-Governmental Organizations (NGOs), Civil Society Organizations (CSOs), Community Based Organizations (CBOs) and indeed the entire citizens of the State, make their contributions into the Budget that will be incorporated for articulation, consolidation into the State propose Budget for transmission to the State House of Assembly for their screening, analysis and passage. It is another way of publicizing Government Policies and Programmes as well as having access to make input into it, hence making the Budget as all inclusive and participatory, with wider acceptance and creating ownership and support from citizens from all angle of the State.

The budget public hearing has become an area of concern by the citizen whereby the general public are having much interest in not only participating but give inputs in the areas of their priority and concern as they defined it, not only that but using it as a medium of tracking the government performance in the areas of basic needs, the outcome of the budget public hearing is resulting into a lot of input coming from different stakeholders and associations such as the NURTW, students Unions, Religious Organizations, butchers associations, farmers and traders organizations State chamber of Commerce, Achaba Riders associations, Market Associations, just to mention but a few.

BASIS/PARAMETERS OF BUDGET

In his welcoming remarks the Honorable Commissioner Ministry of Budget and Economic Planning highlighted some of the basis or factors that are necessary to be considered before formulating or drafting a budget. It is through these factors that the technical officers at the Budget directorate must consider in determining the budget size for each year. These factors includes the exchange rates (Naira-Dollar), current inflationary trend, Crude oil production and sales bench marks, FAAC allocation to the states, Population, etc. these are of paramount important in the development of the Medium Term Expenditure Framework and Fiscal Strategy Paper after which the State Development Plan and State current Agenda as well as the Vision and Mission will be forecast and eventually develop the annual Budget.

2. AIM AND OBJECTIVES

The aim of the Bauchi State Budget Public Hearing is to produce all inclusive and participatory governance by giving the stakeholders an opportunity to make contributions in terms of inputs into the state budget.

3. GOOD WILL MASSAGES
