

**REPORT ON THE
CONDUCT OF THE BAUCHI

INTRODUCTION:

The Honorable Commissioner Ministry of Budget and Economic Planning in his opening remarks explained that the main aim of the Budget Public Hearing (BPH) as a component of the Multi-Year Budgeting framework (MTEF) is to widen the opportunity to the stakeholders at all levels (Non-Governmental Organizations NGOs), Civil Society Organizations (CSOs), Community Based Organizations (CBOs), Persons with Disabilities and indeed the entire citizens of the State, make their contributions into the Budget for articulation, consolidation for transmission to the State House of Assembly for their screening, analysis and passage. Additionally, the Budget Public Hearing is also another way of getting a larger number of the State populace becoming aware of the Government Policies and Programmes as well as having access to make input, hence making the Budget as all inclusive and participatory, with wider acceptance, feeling of ownership and support.

The budget public hearing is becoming an area of concern by the citizen whereby the general public are having much interest in not only participating but give much inputs in the areas of their concern as they defined it, not only that but using it as a medium of tracking the government performance in the areas of basic needs, the outcome of the budget public hearing is resulting into a lot of input coming from different stakeholders and associations such as the Association of Peoples with Disability, butchers associations, farmers and traders organizations State chamber of Commerce, Achaba Riders associations, Market Associations, just to mention but a few.

2. AIM AND OBJECTIVES

The aim of the Bauchi State Budget Public Hearing is to produce all inclusive and participatory governance by giving the stakeholders an opportunity to make contributions in terms of inputs into the state budget.

3. METHODOLOGY

The state is divided into 3 clusters based on the existing 3 Senatorial Districts and conducted separately aimed at giving more chances and opportunities for participation. The presentation was on the proposed 2022 budget using Power Points which centered on the agenda of this administration (Education, Health, Agriculture, Security and Youth and Women Development).

Conduct of Budget Public Hearing in Northern Senatorial District AT AMINU SALEH COLLEGE OF EDUCATION AZARE`.

The BPH was conducted live on air (Radio) on 3rd September, 2021 in the Northern Senatorial District comprising 7 Local Governments as follows; Katagum, Zaki, Gamawa, Itas Gadau, Jama'are, Shira and Giade at the Conference Hall, College of Education, Azare with over 200 participants drawing from different stakeholders which includes; Association of Peoples with Disability, Road Transport Union, Businessmen Association, Achaba Union, Traditional Institution, CSOs, CBOs, FBOs, Trade Union, Student Union, Women Groups, Fish& Meat Sellers, Craft men etc.

WELCOME ADDRESS/OPENNING REMARKS;

The welcome address was delivered by the Commissioner Ministry of Budget and Economic Planning where he welcomed the participants and highlighted on the basis of the State budget which is based on Macro Economic Analysis with particular emphasis on projection of Fiscal Strategy Paper (i.e forecast on revenues and their sources, inflationary trends, exchange rates, oil benchmark) and Medium Term Expenditure Framework. He further explained that the state has adopted a zero based budgeting which centered on proposing a realistic projects in the budget rather than

the previous system of traditional budgeting which was usually ambiguous and unrealistic. He finally called on the attention of the participants to listening carefully at the presentation that will be made by the Permanent Secretary so that they will make observations and contributions that will serve as inputs to be incorporated into the budget to fulfill the aim and objective of the budget public hearing.

TECHNICAL SESSIONS;

2022 Budget presentation (Power Point) was made by the Permanent Secretary Ministry of Budget and Economic Planning after an opening remark by the Commissioner Ministry of Budget and Economic Planning. The presenter concentrates on the ongoing and newly/proposed capital projects contained in the 2021 budget such as the Construction, Renovation and Rehabilitation of Roads, Primary and Secondary Schools, Government offices, Hospitals and purchases of Hospital equipments and Drugs, Student Scholarship. Other Projects includes Provision of water to rural communities, rural electrification, and system strengthening to mention but a few. After the presentation much time was given to the general public/ participants to make comments ask questions and contributions. Many people, CSOs and organizations from different areas of the Senatorial Districts responded by making request for inclusion of their most priority needs into the 2022 budget which are as below;

It is hereby recommended, that the State Budget Public Hearing should be institutionalized (back by law as a State Budget Process) and to be organize and conducted in all the local governments of the State every year for wider coverage and proximity to allow the local peoples attend and give their inputs which will strengthen the public confidence in the State governance.
